

Workshop on Latin-American Strategy for Research Infrastructures (LASF4RI)

Developing a strategy to strengthen Latin American Scientific Collaborations and their impact.

At the III Ministerial meeting of Science and Technology of Ibero-America, held 29-30 October in Guatemala a Ministerial Declaration included the need to further and support the scientific activities of researchers at existing infrastructures and the development of new ones, through specific mechanisms such as the Latin American Strategy for Research Infrastructures (LASF4RI)¹. This document was further ratified at the High-Level Meeting of Heads of State held 15-16 November in Guatemala through the approval action plan, item C.7².

Considering that many Heads of Research Council (HORC) from Latin-America plan to attend to the Annual Meeting of the GRC (Global Research Council) in São Paulo, Brazil next May 1-3, the ICTP and the São Paulo Research Foundation (FAPESP) will organize on April 30 and May 1st a Workshop to discuss the LASF4RI considering Research Infrastructures in all areas of science.

Day 1: April 30. Discussion with LA HORC on strategies for research infrastructures aiming at:

- 1) Convene experiences from Latin-America and other regions that can provide a relevant reference for the development of LASF4RI.
- 2) To build consensus and support for a strategy-based approach for the participation in, and development of, research infrastructure projects in Latin-America.
- 3) To discuss the procedures necessary to build a LA scientific roadmap in relation to research infrastructures, considering the inherent need for long term planning and funding, guaranteeing opportunities for input from the relevant scientific communities.
- 4) To make use of existing Latin American Research Infrastructures to foster more research collaboration in the region, facilitating multilateral participation in regional and global research infrastructures.
- 5) To inform the Ministerial meetings of the development of the LAS4RI.

Day 2: May 1st. Discussion with researchers from Latin-America

During the second day the aim is to have members of the Latin American scientific communities in Particle Physics, Astronomy, and Cosmology provide input for discussion and establish the next steps towards a strategic scientific forum in order to coordinate Latin-American activities in the area.
